 - a. Various activities will be offered throughout the program period. Details of activities will be communicated via program emails and the monthly VC-WELL email digest.
- 2. <u>Complete</u> your selected activities by the stated deadline to earn the points advertised for that activity.
 - a. Points activities are tracked via our vendor portals: WELLtrek, Target Solutions, and Wellbeats. To complete activities, you must have an account for that activity's particular portal.  - b. Scheduling a wellness screening is done on our vendor's scheduler portal and can be accessed via our webpage: <u>https://vcwell.ventura.org/profile/</u>.
- **3.** <u>Monitor</u> your activity points status by checking the points emails periodically sent by Wellness. a. Points status emails are usually sent every 2 months beginning in April.

*The <u>first 200 employees</u> to achieve <u>Gold</u> status will receive \$300, the <u>next 250 employees</u> to achieve <u>Gold or Silver</u> status will receive \$200, and the next 850 employees who achieve <u>Gold</u>. Silver or Bronze status will receive \$100.

New to WELLthy Reward\$? Employees earning a VC-WELL cash award for the first time will receive a <u>\$50 bonus</u> (one-time) added to their 2024 cash award.

✓ Program Eligibility:

- You must be a Regular-class employee participating in the County of Ventura's Flexible Benefits Program to be eligible for the WELLthy Reward\$ Program, and you must receive a paycheck on <u>November 1, 2024</u>, to be eligible to get an award.
- Due to IRS regulations, all cash awards are taxable. Please consult with your tax advisor on any potential impact a cash award may have on your paycheck.
- Cash awards will be limited to the *first 1300 eligible employees* who achieve a status.

- Not all wellness activities offered by VC-WELL will have a point value for this program. Activities that have a point value will be clearly stated and identified in communications such as emails or monthly digest emails.
- **<u>Registration is not required for this program</u>**. Points activities that you complete will be automatically tracked by VC-WELL's various program platforms (Target Solutions, WELLtrek, or Wellbeats) unless otherwise noted.
- If you are unable to participate in any WELLthy Reward\$ activity to earn points because it is unreasonably
 difficult to do so due to a medical condition or because it is medically inadvisable for you to do so, you may be
